3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The OCOF Ending Family Homelessness through Rapid Rehousing (EFHTRR) project targets at least 36 homeless households with children over the project year, or 18 units at any point-in-time, through a scattered-site model using a Housing First low-barrier approach. Although assistance is geared toward a six-month program, the length of assistance is dependent upon the needs of individual participant households as many are single parent households. The Case Manager works in collaboration with the Coordinated Entry Agency (CEA) as well as emergency shelters, community and street outreach, and faith-based groups to identify and prioritize eligible homeless families based on severity of service needs and length of homelessness, including chronic homeless, veterans, LGBTQ, & Domestic Violence survivors. Upon enrollment, services for the participant begin through the rapid rehousing model and using best practices. Housing is located as quickly as possible giving participants' choices while working with landlords to manage participants' risks and barriers. The primary goal of the program is to move participants into stable, long-term permanent housing outside of the project. Placement into local subsidized housing projects is concurrently pursued along with enrollment in mainstream benefits to increase participant income and resources. OCOF RRH works with community partners such as MDHHS, Mid-Michigan Recovery Services, Advent House Ministries, Veteran's Administration, Financial Empowerment Center, and Legal Services. Once independent permanent housing is secured, follow-up case management is initiated for up to six months to further housing stability. Case management may continue another six months if agreeable to participant. Case Management services take place at participants' homes, in the office, or at group outings. The underlying premise of case management is the family reaching the optimum level of housing permanency and functional capability. During the follow-up period, the Case Manager focuses on budgeting, timely payment of rent/utilities/other housing costs and continues to address the underlying cause(s) of homelessness with each client. This project's services, beyond placement into housing, may include - assistance to obtain health insurance such as application and navigation resources/services; employment search; GED prep materials and referrals; access to food programs; tax preparation assistance; energy education, money management and life skills workshops; specialized senior services for age appropriate participants; and, referrals to other community programs as needed. To gauge the success of the program on an ongoing basis, participants are encouraged to complete participant satisfaction surveys. Program success is also gauged by client successfully maintaining housing.
